STUDY METHODOLOGY

Computer assisted telephone interviews (CATI).



TARGET GROUP

Population aged 18-59, residents of mun. Chisinau.



GEOGRAPHY

Mun. Chisinau.



SAMPLE SIZE

1'025 completed interviews with representatives of target group.



PERIOD OF DATA COLLECTION

November- December 2019.





Opinion regarding respect for the rights and freedoms in the Republic of Moldova

















Providing personal information is an increasingly important aspect today


Government (state institutions) demand more and more personal information

In order to benefit from certain services / products it is necessary to provide personal information






Level of protection of personal data by institutions














